## Introduction

Welcome to the Behavior & Enrichment Academy and Resources (BEAR). BEAR is an innovative educational program developed by Shelter Playgroup Alliance (SPA). Our policies and procedures are designed to ensure a positive and enriching experience for all participants. By enrolling in the BEAR program, participants agree to abide by the following guidelines.

## **Admission Requirements**

Individuals that meet the following requirements may enroll in the BEAR program.

- Able to speak, listen, read, and write in English at an 8th grade level, or provide their own accommodation.
- Aged 18 or older.
- Have daily access to high-speed internet.
- Have daily access to a video camera or a phone with video capabilities.
- Have weekly access to more than one species of animal.
- Have weekly access to dogs in a shelter or rescue (not one's own dog).
- Ability to lift up to 50 lbs, stand, walk, stoop, bend, squat, kneel, grasp, grip, put fingers together firmly, and reach above and below shoulder level.

The BEAR program follows a model of incremental and sequential learning, wherein successful completion of one phase is a prerequisite for progressing to each subsequent phase. This sequential approach ensures a structured and comprehensive learning experience, building on the foundation established in earlier modules and phases before introducing more advanced concepts and skills.

Individuals who have completed the SPA CORE program in 2022 or 2023 are approved to bypass Phase One – BEAR Necessities (online) and move directly to the Phase One - BEAR Necessities Workshop (in-person). Prospective participants who believe that they have completed an equivalent program can submit those program details for review of equivalency. A full course list can be found in the program overview section. Participants will review dates prior to registration to ensure that they are able to adhere to the required time commitment. Cost of travel and accommodation for the in-person workshops are the responsibility of the participant and are not included in the workshop registration fee.

The location of in-person workshops will be announced at least six months prior to the workshop.

Refunds will be issued in full if a cancellation request is received 30 days prior to the cohort or workshop start date. In the event that a cohort or workshop is canceled, registered participants will be given the option to remain enrolled for future cohorts or receive a full refund of their registration fee.

All refund requests must be submitted in writing to mara@shelterdogplay.org with the subject line "refund request". Please include participants' full name, contact information, current cohort, workshop date, and reason for the refund request in the email.

If participants would like to transfer registration to another qualified individual, please notify us in writing of the substitute attendee's name and contact information at least 14 days prior to the start of the program. Prerequisites for each phase apply to all individual participants.

No refunds will be issued for registered participants who do not attend the cohorts or workshops without prior notice.

## Equipment

The LITMOS Learning Management System platform is used for the majority of the program content and Zoom is used for live virtual sessions. Daily access to a computer and video recording device, such as a GoPro or phone-based video device, is required. Daily access to a reliable high-speed internet connection for accessing learning content and uploading documents and videos.

Videos can be submitted in the following ways: If the video file is smaller than 250MB, participants may upload it to LITMOS for review. If the video file is larger than 250MB, participants can provide a link to the file in the comments section of the submission. In order to expedite the review process, please make sure that we have access to your files. If a participant's submission includes a link to a video on the participant's YouTube channel, please make sure that it is set to "public" or "unlisted, available to anyone with the link". If video is shared via Google drive, please make sure that the link is available to anyone with the link. Not all of the graders use Apple products, so please avoid using Apple mail drop to submit videos.

Participants will require access to more than one species of animal and need regular access to dogs in a shelter or rescue. Participants will need a long slip lead (10 or 12 feet), a treat pouch, a clicker, and daily access to high-quality treats for dogs and a second species.

## Commitment

Participants are expected to demonstrate a commitment to the program. This commitment involves active engagement in online self-paced learning modules, attendance to any required live virtual sessions and in-person workshops for full completion of the course. Regular participation and completion of assignments contribute to a successful learning experience.

## Accommodations and Accessibility

Requests for reasonable accommodations for participants with disabilities or special needs can be made by emailing <u>mara@shelterdogplay.org</u>. ## **Online learning**

BEAR provides a flexible online learning environment for participants. Participants should be prepared to spend up to **3-4 hours per week** on the program for successful completion. It is the responsibility of each participant to manage their time effectively and complete assigned modules within the allotted time frame. Participants will access online learning modules at their own pace, demonstrating understanding of new skills by submitting written assessments and recorded video of interactions with sheltered animals. At each step, participants can expect to receive targeted coaching and feedback on training, behavior modification, and behavioral observations.

Extensions beyond the specified end date for each cohort are unavailable, as this timeframe is dedicated to program content review and renewal between cohorts. Participants seeking to continue with online phases after the designated end date may do so by registering for a subsequent cohort, subject to an additional registration fee.

## In-person workshops

Participants must attend all days of scheduled in-person sessions. Workshops associated with each phase must be taken within 18 months of completion of that phase. All costs associated with travel, accommodation and associated personal expenses are at the expense of the participant or participant's employer. Daily lunches and light refreshments will be provided on each workshop day. Breakfasts and dinners are not included. In the event of unforeseen circumstances preventing attendance, participants should notify <u>mara@shelterdogplay.org</u> as soon as possible. Any missed sessions may impact program completion.

## **Grading & Evaluation**

Participants will be assessed based on their understanding and application of course content by a team of experienced shelter behavior professionals. The evaluation standards for each assessment and assignment are regulated by a structured rubric. Feedback will be provided to aid in continuous improvement and grading is on a 100-point scale. We aim to grade all assessments within a 24-hour period.

## Ethics, Integrity, and Plagiarism Policy

Participants are expected to act in an ethical manner and with integrity. Specifically, the videos and accompanying materials are for BEAR participants only, and may not be shared with non-participants. Participant passwords are for individual use only, and may not be shared with non-participants or other participants. Taking of screenshots or recording the course's videos and accompanying materials, or providing them to non-participants for any use is strictly prohibited, including on social media. Participants must take each module in its entirety and acknowledge that fast forwarding through the recorded lectures is an ethics and integrity

violation. Participants who engage in any ethics, integrity, or plagiarism violations are subject to removal from the program and ineligibility for future cohorts.

According to the Mirriam Webster dictionary, plagiarism is "to steal and pass off (the ideas or words of another) as one's own : use (another's production) without crediting the source" (*source*: <u>https://www.merriam-webster.com/dictionary/plagiarize</u>)</u>. Participants in the BEAR program are expected to credit sources in all written assignments. Participants who misrepresent the provenance of information, opinions, and assessments are subject to removal from the program and ineligibility for future cohorts.

## **Continuing Education Units**

CEUs are submitted a few weeks after the completion of the cohort. KPA, IAABC, and CCPDT all grant CEUs for successful completion for each phase of the program. The phase one on-line portion of the program is approved for 30 CEUs for CCPDT and 36 CEUs for IAABC.

## Phase 1

**BEAR Necessities (on-line):** In this initial phase of the program, we will be exploring the necessary and foundational concepts for the participants' journey to becoming a shelter behavior professional.... the BEAR Necessities! This set of on-line courses will cover key concepts that include how animals learn and communicate, positive reinforcement-based training and behavior modification, ethics related to sheltering and animal training, and enrichment in the shelter environment, including the implementation of inter-dog interactions. (\$300/person)

**BEAR Necessities Workshop (in-person):** The prerequisite for the first workshop is successful completion of the BEAR Necessities modules. This hands-on workshop will build on the content in the BEAR Necessities modules and consists of four consecutive days during which participants will demonstrate safe handling, defensive handling, behavior modification for cats and dogs, low stress handling for cats and dogs, and manage safe inter-dog interactions. (\$800/person)

## Phase 2

**BEAR Fundamentals (on-line):** The second phase of the BEAR program explores the differences between evaluations and assessments, types of evaluations, risk assessment, gathering and documenting objective behavioral information, identifying manageable behavioral concerns, prioritizing interventions to focus on behaviors that may limit opportunities for placement, and engaging with community members in a variety of situations. Enrollment in BEAR Fundamentals is contingent upon successful completion of BEAR Necessities, or equivalent\*. (\$300/person)

**BEAR Fundamentals Workshop (in-person):** The prerequisite for this workshop is successful completion of the BEAR Fundamentals modules and Phase One on-line and in-person content. This hands-on workshop will build on all of the previous content and consists of five consecutive days during which participants will engage in conducting evaluations, identifying and problem-solving behavior concerns, conducting canine risk assessments, creating behavior modification plans for multiple species, and working with the public. (\$800/person)

(\$800/person)
